About 14 states provide some type of coverage or mandate that coverage be offered to employers (but not necessarily provided to patients), with fewer than 5 providing extensive coverage, all having some limitations. Many patients have coverage for diagnostic tests but not for treatment, or have lifetime limits on infertility treatments. Some patients have very good coverage, e.g. up to 3 complete cycles, with private insurance. It is estimated that nationally approximatly 20% of all ART costs are covered by government mandate of private insurers and/or by private insurers.
